SUBJECT: Measure BP- Investment Opportunity Categories- Formulation and Prioritization - Continued from 10/10/2023 Meeting

SUMMARY

In line with the early work of the SOC following its inaugural meeting of August 8, 2023, this staff report begins the process of developing a framework by which the SOC can consider and review proposals for projects, programs, and initiatives, in deciding whether to advance them as a recommendation to the City Council. The framework will establish investment opportunity categories with a prioritization system within each (subcategories).

RECOMMENDATION

It is recommended that the Members of the Measure BP Stakeholders Oversight Committee adopt a categorization and prioritization framework for Measure BP project proposals that the SOC will utilize in advancing its recommendations to the City Council. The CEO is herein presenting a draft framework for the SOC's discussion and consideration.

FISCAL IMPACT

All proposals presented to the SOC, by definition, will be funding requests for Measure BP funds. The fiscal impact will be determined based on the estimated cost of each project, program, or initiative that the SOC decides to advance as a recommendation to the City Council.

BACKGROUND

At its meeting of August 8, 2023, the SOC considered a presentation on the development timeline of Measure BP leading up its ultimate passage by the Baldwin Park voters on November 8, 2022. The presentation also highlighted the primary responsibility of the SOC, which is to be the representative of the community in prioritizing and recommending investment opportunities to the City Council. Developing a prioritization methodology is essential to enabling the SOC to approach its recommendation-making duty in a systematic fashion.

DISCUSSION

Measure BP presents the City with a special opportunity to effectuate quality of life improvements for the benefit of its residents, some of which will have a life-long and beyond lasting effect. The voters placed their trust in the City by approving such a measure. The City Council, the SOC, and the Staff of the City are fully and unconditionally committed to upholding the trust of the voters in ensuring that funds of Measure BP are invested wisely, prudently, transparently, and always for the ultimate benefit of the City residents.

To that effect, a draft framework for establishing a prioritization system in a systematic and transparent way is presented for the SOC's discussion and consideration. It is presented as a draft as a starting point for the SOC to further discuss and refine as they deem appropriate.

Investment Opportunity Categories

The recommended nomenclature for organizing proposals of similar or related themes with the intent of leveraging the maximum benefit from each proposed investment is as follows, with the categories listed in alphabetical order:

- A. City and Community Empowerment
- B. City Workforce Development
- C. Economic Development
- D. Public Safety
- E. Recreation and Parks
- F. Senior Community
- G. Sports Development
- H. Street Infrastructure
- I. Youth Development
- J. Miscellaneous

In further refining more specific topics for project proposals, following is a listing of subcategories within each category, which is where the first layer of prioritization will be established. SUBJECT: Sports Complex Project- Conceptual Visioning Process
- Continued from 10/10/2023

SUMMARY

The idea of a sports complex in and for the City of Baldwin Park residents came up during the educational phase of the Measure BP ballot measure. It was also one of the salient projects that Measure BP could make a reality during the City Council deliberations about placing Measure BP on the ballot. It was presented as an idea to the SOC in its inaugural meeting of August 8, 2023. This report begins the public visioning phase where the range of the scope of what the sports complex project ought to encompass, no matter how ambitious or modest the scope ends up being.

RECOMMENDATION

Chair Lara (and Councilmember Damian) provided testimony to the Baldwin Park Unified School District Board of Education at its meeting of October 24, 2023, in support of dedicating closed school sites for sports facilities and open space.

Chief Executive Officer recommends that the SOC hold a discussion on strategies to more effectively pursue the partnership with BPUSD for open space and sports facilities.

FISCAL IMPACT

The estimated cost of a sports complex will be dependent on the scope of it. Only intended to be a very general guide at this juncture, the cost can range between \$15 Million and \$60 Million.

BACKGROUND

Sports activities are an integral part of our city's societal culture. It is certainly true for our youth, but it is also holds true for our adult community. Outside of school-based sports facilities, and those provided by the City at Morgan Park at the Esther Snyder Community Center, the City is lacking a sports facility infrastructure that is accessible to all age and gender groups of our community, enabling those who participate in competitive sports to be on a "level field" with those that they compete against. Success in sports is a source of pride for our community, and sporting activities in general promote the physical well-being of our residents.

DISCUSSION

Providing adequate sports facilities for residents to practice a sport of their choice has elevated in importance for the City to support the needs and wants of its residents. It is part and parcel of the quality of life in the City. While the aspiration of a sports complex had been on the minds of many, especially of those more closely involved in sports activities, it was not until recently that such an aspiration began to appear more and more as potential reality, given two significant events taking place: suitable property

sites potentially becoming available as the Baldwin Park Unified School District has undertaken a school decommissioning initiative with two school sites already closed and more sites currently under review for closure; and the voters of Baldwin Park approving the passage of Measure BP, therein providing a source of funding for the sports complex.

Moving one step further in the development of the concept, we propose to begin a visioning exercise where the scope of the sports complex will largely be defined. It is in this stage where we define what the sports complex should include, i.e. outdoor sports, indoor sports, aquatics, pickle ball, tennis, walking, running, etc.

To facilitate the visualization of the range of the scope, we have compiled a list of reference facilities that offer the opportunity to see, feel, and touch a particular feature. Not one of the facilities is intended to be a replica of what we think Baldwin Park ought to have; rather a particular feature of it. For example, the YMCA Sports Complex in the City of Upland features a state of the art aquatics facility.

Following is the list of proposed reference facilities for consideration for a site visit by the SOC, in random order:

1. Chino Hills Community Park, Chino Hills
2. Discovery Sports Complex, Downey
3. Scheu Family YMCA, Upland
4. KARE Youth Sports Complex, Irwindale
5. La Pente City Park, La Puente
6. West Covina Sports Complex, West Covina
7. South Gate Sports Center, South Gate
8. Bell Gardens Sports Park, Bell Gardens
9. Orangewood Park, West Covina
10. Fremont Park, Glendale
11. Pacific Park, Glendale

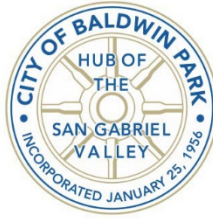
The logistics and time availability of the SOC members may determine how many sites are visited; a minimum of four locations are recommended with two days allocated to conduct the visits.
